The application received on dt.11/05/2023 for renewal of building I only. (G+1)

On Dt.12.05.2023 the inspection carried out and found that the present Fire Fighting arrangement and fire safety arrangements are in working condition which was stated in Provisional Fire No Objection Certificate No. MADC MIHAN/FIRE/2771 Dt.25.11.2009 which was cancelled and amended Provisional fire No Objection Certificate No.2062/MIHAN/FIRE/2013 dt.15.05.2013. Therefore the renewal is hereby granted on following term & conditions.

**Terms & conditions:-**

- 1) The remaining building constructed should not be occupied without obtaining Completion/Final Fire No Objection Certificate.
- 2) Owner/Applicant should renewal this certificate every year.
- 3) Storage of Inflammable material/Liquid in this building is not permitted.





- 4) It shall be insured that all staff with security of the building are trained in handling firefighting equipment & installation.
- 5) All firefighting equipment & installation shall be well maintained and should be easy assessable.
- 6) MADC reserves right to amend/change conditions or impose new conditions considering the safety requirement of life an property.
- 7) The conditions of the certificate shall be binding not only to the applicant but also its successors and every persons deriving title through or under them.
- 8) After completion of remaining blocks the applicant/owner should apply for Provisional Fire No Objection Certificate from Fire Officer MADC Nagpur.
- 9) First Aid Fire Fighting & Mock drill should be conducted twice in a year and should inform MADC Fire Dept.
- 10) No Mobile tower is permitted without permission of MADC Ltd., Nagpur.
- 11) Every six month applicant/occupier will inform in return that all firefighting equipment & installation are in working condition.
- 12) During the inspection if the firefighting equipments & installations are not found working condition this certificate can be cancelled without preinformation,
- 13) Applicant to submit form B along with the application for renewal.


