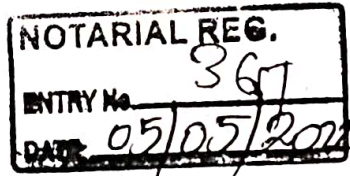



- That no matter related to the trust/ organization/ school is subject to prejudice

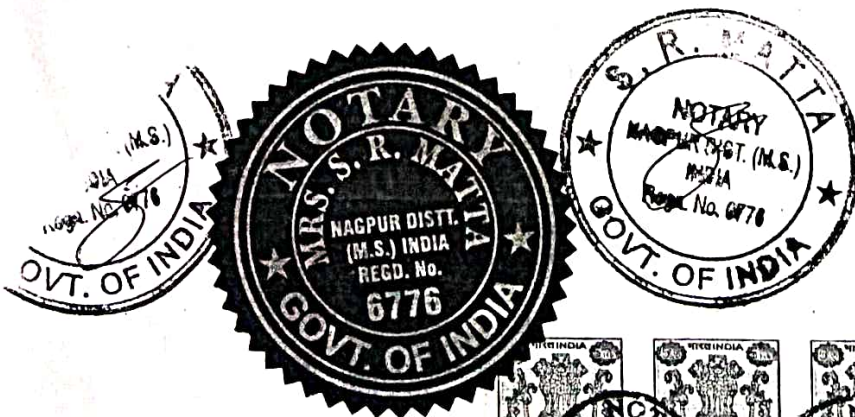
